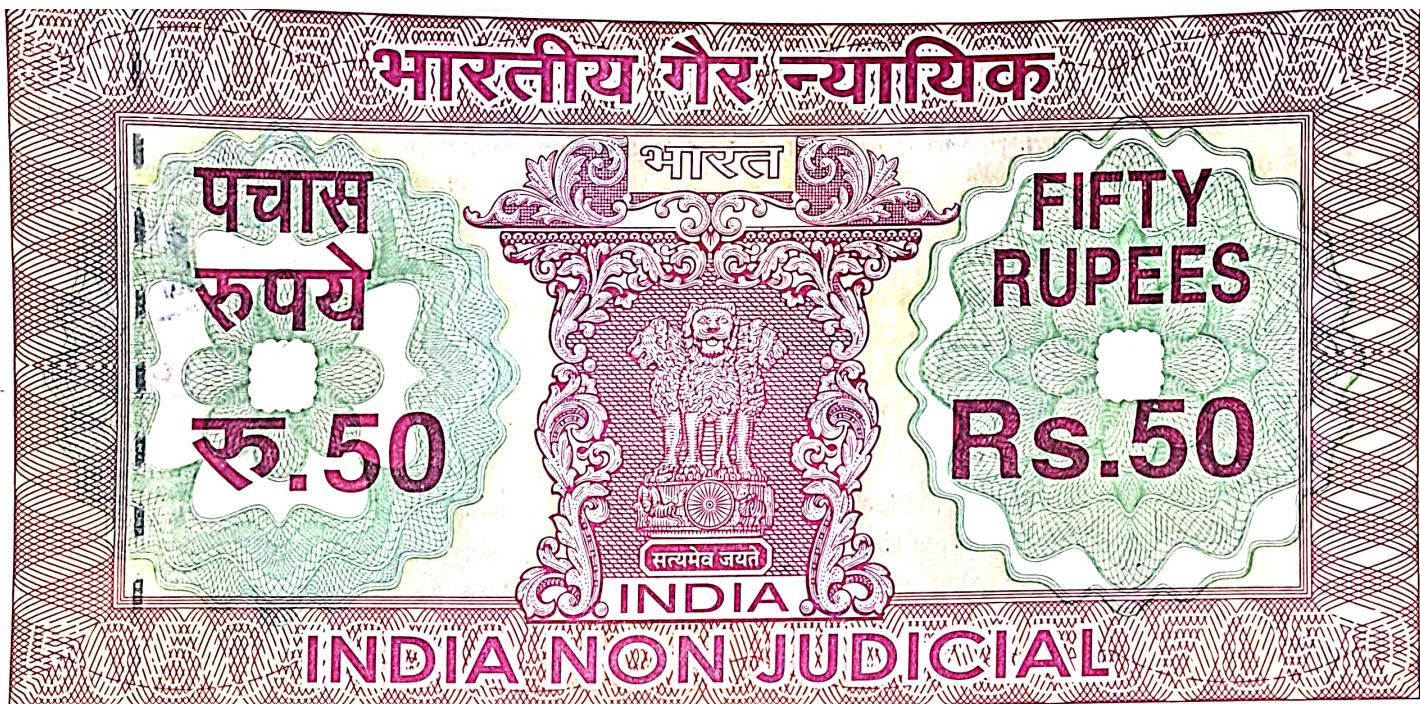

MEMORANDUM OF UNDERSTANDING (M.U.)

Between
Sandipani Academy, Bonda (District-Bilaspur) (S.A.)

1. Purpose

4. Liability

Loss or damages caused through gross negligence or intent, the Parties shall have no liability to each other here under.

5. Legal Relationship

This MoU constructed as a statement of purpose to promote a genuine and mutually beneficial collaboration between the Parties. Nothing in this MoU shall create any legal relationship between the Parties.

6. Commencement, Renewal, Termination

This MoU will be effective from the date of the last signature hereto and will remain in force for a time period of 5 years, with a possibility for renewal at the end of the two-year- period, subject to the Parties' written agreement. Either Party may terminate this MoU by giving 1 months' notice in writing to the other Party.

7. General Coordinators

Each Party shall designate an administrative office to oversee and facilitate the implementation of any agreements arising out of this MOU.
